It is the condition of entry that each exhibitor shall hold the horse show, the facility & it's management blameless for any loss or accident to any animal, person or property that may occur while on the premises or during the show. I further agree that I will not hold Horse Show Services, LLC, Simon Horse Company or their owners or employees responsible should I develop symptoms of or receive a diagnosis of COVID-19 during or following this event. Furthermore, I agree to ride/drive at my own risk and hold harmless any other owner or exhibitor from any accident or injury sustained by me or my horse while participating in this event.

Submission of an entry to this this show constitutes agreement of the following: The exhibitor shall indemnify and hold harmless Horse Show Services, Simon Horse Company or its managers and their respective agents, contractors, officers, employees, directors, shareholders and assigns (together the "indemnities") harmless against any and all claims, demands, costs, and expenses, including reasonable legal fees, arising from the conduct of management of Exhibitor's business or it's use of the facilities of Simon Horse Company from any breach on the part of the Exhibitor, it's agents, contractors, employees, guests or invitees in/on the property of Simon Horse Company. If any action or proceeding is brought against an indemnity by reason of any such claim, the Exhibitor, upon notice from the Indemnity shall defend the action or proceeding by counsel acceptable to the Indemnity.
